Position Description

The BACCHUS State Coordinator is responsible for

- Communication with state members about programs, services, and professional development opportunities available to them through the BACCHUS Initiatives of NASPA.
- Serving as the 'welcome committee' for new members, introducing members to the BACCHUS Initiatives of NASPA professional development opportunities and contacts within the state.
- Sending a "beginning of the year" email should be sent to all members in the State Coordinator's state, reminding them of his/her presence as a local resource.
- Offering support to campus members who are struggling or just getting started.
- Assisting the NASPA staff and the BACCHUS Regional Consultant in member recruitment.
- Working with the regional team consisting of the BACCHUS Regional Consultant, BACCHUS State Coordinators, and the Student Advisory Committee (SAC) member to advance the goals set for the area.

Qualifications

We are seeking enthusiastic NASPA professional affiliate members working in the listed states to apply for this position. The core requirements for state coordinators are:

- State coordinators must be a NASPA Professional Affiliate member working at a NASPA Institutional Member campus.
- State coordinators must be professionals working in some capacity of student affairs, wellness or health promotion.
- State coordinators must have experience advising a peer education program.
- State coordinators should be on a campus that has an active BACCHUS Initiatives of NASPA member peer education group.
- State coordinators should have a working knowledge of the programs, services and philosophy of **the BACCHUS Initiatives of NASPA**, so they will be able to act as a spokesperson for this organization with relative ease.
- State coordinators are urged to discuss the state coordinator role with, and get the support of, their supervisors.
