# Reflections on the 2015 NASPA Assessment and Persistence Conference

This year's Assessment and Persistence Conference was hosted in historic Boston, Massachusetts, which provided a perfect backdrop to think about where we have been, where we are, and where we are going as a profession. The opening speaker, Dr. Estela Mara Bensimon, reminded us of the structural inequality that has been in place in higher education, but also spoke about the excellent programs currently in place that help students of color excel. Dr. Donna Younger challenged us to think deeply about the needs of adult students and how we design our programs, services, and systems to better serve this growing population. The vice presidents' panel (Marva Craig, Mitchell Levy, Jason Meriwether, and Greg Sammons) focused on student engagement and success, adding interesting perspectives about the political environment on college campuses. Although the final speaker couldn't make it, Ted Elling, Michael Christakis, Jeanna Mastrodicasa, and I filled in to peer into our crystal balls to predict the future of student affairs assessment.

The high quality concurrent sessions focused on assessment methods, retention of special populations, fundamentals of assessment, integrated assessment and persistence practice, and more. As a more seasoned assessment professional, I enjoyed the intermediate and advanced sessions, but there were plenty of sessions for those new to the profession as well. While some sessions were more theoretical, others were very practical. Sessions were presented by faculty, student affairs assessment professionals, and program coordinators so there was a breadth of prspectives. I loved hearing the deep conversations taking place and seeing the passion that participants had for improving the higher education system. On a more personal level, I enjoyed connecting with the colleagues I only see once or twice a year. We catch up on families, friends, pets, campus politics, and new jobs as if we have not been apart at all.

A few of the reflection questions I noted:

- What systems and support do we have for students as they transition in and out of our campuses?
- How do we assess what we do on a regular basis so that it provides actionable results, without overburdening already hard working staff?
- How do we "tell our story" to the right people in the right way at the right time?
- How can we partner with faculty to help graduate students learn about assessment?
- How do we know our programs actually accomplish what we say they do?
- What skills do we need to continue to develop to meet the continuing assessment demands?

I'm always excited about APC, since it brings my two passions together—assessment and professional development. I am thankful that NASPA sees assessment and persistence as a student affairs priority and plans an annual conference. I hope I will see you in Portland, Oregon, June 16-18, 2016 for the next conference!

# INNOVATION AWARD WINNER 2015: Danthai Xayaphanh, University of Arizona

We are pleased to announce the recipient of the **third annual NASPA Assessment**, **Evaluation and Research Knowledge Community Innovation Award**, *Danthai Xayaphanh from The University of Arizona for the innovative assessment of Vivir Mexico: Culture*, *History and People*, *a short-term study abroad experience*.

The Assessment, Evaluation and Research Knowledge Community Innovation Award recognizes and honors our innovative colleagues in the field of Student Affairs Assessment.

Danthai Xayaphanh and Vivir Mexico: Culture, History and People, The University of Arizona - 2015 Innovation Award Recipient

Additional support on this innovative assessment project was provided by Marla Franco, Director of Divisional Assessment at the University of Arizona.

The assessment of Vivir Mexico: Culture, History and People aimed to improve the University of Arizona's (UA) understanding of participant outcomes associated with experiencing a short-term study abroad experience. With the support of Assessment & Research and participating faculty and staff, a robust and sustainable assessment plan was developed in spring 2014 and will continue to guide programmatic efforts, data collection procedures, and communication related to the program's impact on student learning.

This program is a result of collaborations between Student Affairs and the College of Education, offering students a 5 week 6-credit hour experience to familiarize them with the history, culture, and society of Mexico and the heritage of Mexican-Americans/Chicanos in the U.S. through intensive study and direct personal experiences in Mexico. In spring 2014, 16 students participated in the Vivir Mexico: Culture, History & People Study Abroad Program, which included face-to-face sessions before students departed to Mexico, content and activities in an online learning management system, an abroad service learning project, along with other enriching in-country experiences led by a faculty expert.

The program's content was intentionally designed with 9 ways for students to demonstrate learning outcomes throughout their experiences. Data collection methods included: 1) program application, 2) daily reflections, 3) video commercials created as a group project, 4) individual digital stories created in VoiceThread (a visual discussion board), 5) photos and videos taken during the experience to be used in both the commercials and digital stories, 6) a closed Facebook group, 7) both pre and post assessments, 8) the creation of a service learning project, and 9) a final reflective essay.

The daily reflections supported deeper levels of learning and assist students in completing other assessments. Each day, students were asked to reflect on their daily experiences and respond to three questions. This helped students to focus on specific topics or leadership outcomes and proved instrumental in guiding students to produce richer commercials and digital stories.

The digital storytelling project provided students a multidimensional way to explore and share a rich learning experience. The stories enabled students to document personal reflections of their experience in Mexico and share the impact the journey had upon their lives.

Data analysis was conducted by two Assessment and Research staff (nonparticipants) and member check occurred with program staff (participants). Data revealed students experienced gains in the following domains: cognitive skills, global perspective, appreciation for diversity, and awareness of self and others. Findings suggested a need to reevaluate the learning outcomes stated on the syllabus to ensure congruency between expected learning and program content.

The assessment approach used has been transformative on many levels and has had far reaching implications for the program itself, for other units and departments in the Division of Student Affairs, and is quickly being perceived as a best practice at the UA for creatively engaging students in reflective processes, assessing for student learning, and completing the assessment cycle by communicating findings and further refining the program based on findings.

The program has shifted from assessing student satisfaction to assessing student learning. This is the first time that data was collected using VoiceThread and the first time that the closed Facebook group and student created videos were treated as data. This was also the first time data was analyzed this extensively and communicated in a summary of findings and published on the UA Assessment & Research website, exemplified for demonstrating a culture of evidence.


