1 FFDFRAI UPF	

- In total, only three higher education bills have been enacted in the last 6 months, 2 have passed both chambers, 10 have passed one chamber, and 17 have been introduced. Topics range from research, transparency, low-income student completion gap, mental health to public safety. Highlights are included here:
 - Student Borrower Protections (see updates under Section 3 "Financial Aid")
 - Closing the Completion Gap \$7 million in <u>grants</u> to support success of students with disabilities; ASPIRE Act of 2016 aims to increase access for low-income and marginalized students
 - <u>Mental Health First Aid Act of 2015</u> ordered to be amended and reauthorized to provide continuing education and training for emergency service personnel, police, teachers and administrators, students, parents, and veterans.

2. TITLE IX UPDATES

In 2016, 22+ states introduce or enacted legislation; 16 states include measures that address 4
primary themes: defining affirmative consent; role of local law enforcement; transcription
notation; and role of legal council. For more information, check out <u>ECS Final Report:</u>

3. FINANCIAL AID

Student Loan Repayment Act of 2016, introduced September 27, 2016. Aims to ame

"Student Aid Bill of Rights" proposed in March 2015, last action was October 2016 release of requirement for <u>Federal Student Loan Servicing System</u> and <u>final regulations</u> to protect student loan borrowers from predatory institutions.

SIMPLE Act, introduced September 8. No updates since last newsletter. Aims to reduce student loan default by enrolling new students who are delinquent into income-driven repayment plans and automating annual recertification of income.
