He is the author of more than 50 academic publications including Shelter: Where Harvard Meets the Homeless (Bloomsbury, 2010) and Character Compass: How Powerful School Culture Can Point Students Toward Success (Harvard Education, 2012), which won the American Educational Research Association's outstanding book award in moral development and education. His current work—supported by a 2013 National Academy of Education Postdoctoral Fellowship—investigates the development of critical consciousness in urban adolescents. # Stewart Generates Reviews of Ground-Breaking Books in Student Affairs and Higher Education

The Dafina-Lazarus Stewart is associate professor in the Department of Higher Education and Student Affairs at Bowling Green State University. She is the contributing editor of the What They're Reading column of the JCC. She focuses her research on issues of diversity and social justice, particularly through lenses of race and ethnicity, sexuality and gender, and religion and faith as they relate to identity, student outcomes, and institutional transformation informed by an intersectional perspective. In addition to publishing widely in higher education journals, she edited the volume Multicultural Student Services on Campus: Building Bridges, Re-visioning Community (2011), and is currently working to complete an oral history. She regularly presents at conferences and workshops across the country. She most recently reviewed When Diversity Drops: Race, Religion, and Affirmative Action in Higher Education by Julie Park.

## Mather to Chair NASPA Sessions and Lead Online Conversation on Advocacy

Peter Mather, associate professor and secretary of the board of trustees at Ohio University, and senior associate editor of the *JCC* will lead a special *JCC* session at the 2015 NASPA annual conference. The session "Navigating Student Activism and Advocacy with Courage" explores how student affairs administrators occupy unique and strategic positions in working with student activists who champion institutional and social change. The session features authors of JCC articles on the topics of student advocacy and activism. Presenters will provide an overview of their research and engage participants in exploring ways in which student affairs professionals can "Navigate with Courage" their important dual roles in supporting this important form of student engagement, while also maintaining their roles as institutional stewards.

As a means to prepare for—and promote—discussion, authors presenting at the session and others will participate in an online dialogue on *JCC's* newly launched blog JCC Connexions, facilitated by Mather prior to the session. Perspectives from this online discussion will be integrated in the session dialogue and presentation, and those attending the session are encouraged to join in the online discussion after the session in order to extend the conversation about student activism and advocacy.
