Professional Development and Engagement

March 2019 – July 2019 Activities

- Incoming Regional Board meeting- March 10, 2019 in Los Angeles, California.
- Regional Board Call- May 3, 2019
- Summer Board Meeting- May 29-31, 2019- Des Moines, Iowa
 - During the Region IV-East Board meeting, we had a discussion about the NASPA Goals and the Region IV-East Strategic Priorities and how they are connected. We looked at what our region is currently doing and what we should and could be doing to advance our strategic plan. We also discussed our vision and the critical issues facing our region. We will then use the identified critical issues to shape our strategic focus. Over the next few months we will continue to identify the top two (2) priorities in each area of the Region IV-East Strategic Priorities and then create an action plan for each of the top two (2) priorities.

Key March-July 2019 Initiatives/Planning

1. Regional Awards/Grants

Revamping and launching the Regional Awards process to include new approved qualifications and a more user-friendly submission process. Launching research and assessment grants application

process where proposals are due by early September and grants are awarded at the Regional conference in November.

2. NASPA IV-East Regional Conference- November 2-5, 2019 *Des Moines, Marriott, Des Moines, Iowa*

Planning is underway for the Regional Conference. We are expecting over 400 colleagues to engage in professional development around this year's theme: *Rooted in our Values; Advocating for Change*

This year's theme acknowledges the history from which our profession has developed. From its strong foundation, as student affairs professionals we are able to extend in different directions to meet the needs of the diverse students we serve. We advocate for change to address inequality and injustice while poised to support the future of our students and our profession. This year's theme is also a nod to our host state, Iowa, as we will be there only weeks before the Iowa Caucuses kick off the 2020 presidential election.

Major Speakers: We have confirmed all 3 major speakers. Each speaker provides firsthand experiences that relate to the values of our profession and our conference theme.

Program Tracks: We will be using carefully selected program tracks to assist participants in identifying programs of interest to them. A committee member connected to the functional area/population is coordinating each track, as well as encouraging program submissions to support the track. The program tracks are:

- SSAO Track
- Student Success
- KC Roundtables and Sponsored Sessions
- Community College Track

Of note, the Community College track is being developed in partnership with the Community College Division. It will offer a series of program sessions that draw from the Community College Division's resources. This is an important addition to the conference as this summer's regional community college symposium had to be cancelled. The Conference Committee is pleased to be able to work with the Division to address the needs of participants who had planned to attend the symposium.

Institutes and Pre-Conferences: In addition to our annual SALT/NUFP Institute for undergraduates and our SSAO Institute, we are adding three pre-conference opportunities this year.

- Mid-Level Institute
- Master's Case Competition

- Advocacy-focused Pre-Conference

3. CSAO Engagement Assessment

- Surveyed Region IV-East CSAOs to learn about their interests in a CSAO Institute at the fall regional conference
- Used the survey results to:
 - Initiate planning for the institute
 - Recruit volunteers to assist with planning

4. Regional Engagement Coordination- Created a board position with the charge of ensuring that all regional planning and event coordination is aligned and resources including funding and volunteers are centralized and communicated. Future plans include:

- Hosting monthly webinars on various professional development topics beginning in August 2019.
- Working with KC Co-Coordinators to encourage KCs to broaden the meaning of engagement to add value to NASPA's membership.
- Supporting all regional board positions that align with engagement via collaboration and idea generation.

 2. **The Board has made a commitment to increasing access to our profession but fully underwriting the cost of the SALT/NUFP conference for undergraduate students in our region, trying to minimize the barrier of cost to entry to our profession.**
