MISSION RELATED ACTIVITIES

- **Higher Education Mental Health Alliance (HEMHA):** In representing NASPA within the Higher Education Mental Health Alliance (HEMHA), I'm pleased to report that the group continues to work hard on its two year project developing a Postvention guide. The goal is to create a short document that could be used in the midst of a crisis (approximately 15-20 pages). NASPA has agreed to serve as host of HEMHA's meeting in 2015 at our annual conference in New Orleans.
- **NASPA Board Chair Elect Candidates:** Final steps are being completed to determine candidates for the NASPA Chair-Elect slate. The fall included time spent contacting those under consideration, processing their interest and providing a clear understanding of and expectations of the role. Candidates will be presented to the Executive Committee, Nominations and Resolutions Committee and proposed slate to the Board of Directors at the December meeting.
- **Presidential Review Process:** The Presidential Review Committee will present the results of the annual review of the NASPA President's performance. We are on schedule for providing a summary of the findings to the President and Board of Directors at our December 2013 meeting.
