Regional Director's Report

I am pleased that the NASPA2 Advisory Board recently approved the Region's new strategic plan while we were together in New York City for our Regional Conference. The new strategic plan outlines four broad priorities:

1. ***Focus on Our Future*** - Expand access for undergraduate students, graduate students and new professionals to NASPA2 programs, services and activities.
2. ***Prepare Mid-Level Professionals to Lead*** - Introduce high-impact professional development opportunities for mid-level Student Affairs professionals throughout NASPA2.
3. ***Innovate Our Work*** - Provide opportunities to discover and discuss new and innovative strategies that address current issues in higher education.
4. ***Commitment to Community Colleges and Two-Year Institutions*** - Develop and deliver programs focused on supporting student affairs work at community colleges and two-year institutions throughout NASPA2.

NASPA2 has already begun to realize elements of the plan – introducing Career Connections, developing a new, expanded Careers in Student Affairs month initiative, expanding the Senior Leadership Institute to include AVPs, and engaging faculty around issues of graduate preparation program curriculum.

I am confident that our new regional strategic plan provides an important roadmap for NASPA2's work, while allowing room for necessary innovation in how we deliver programs and services to our members.

Finally, the Advisory Board formally approved a joint regional conference with NASPA3 June 8-11, 2019 in Washington, DC as well as sites for the 2020 (Niagara Falls) and 2021 (New York City) regional conferences.

Public Policy Update

This session will address the current public policy landscape with a focus on issues that are critical to student affairs professionals. The session will start with a presentation of national and state higher education policy issues and developments, possible implications for student affairs divisions, and a brief review of NASPA’s public policy agenda. Topics will include campus responsibilities for prevention and adjudication of sexual misconduct cases under Title IX; state legislative proposals related to free speech on college campuses, rights for trans students, and authorization of concealed carry on campus; and recent legislative proposals for the reauthorization of the Higher Education Act, including student aid programs and support for under-represented populations. The session will conclude with a moderated discussion of how public policy is impacting campus-level decisions.

 - a. Introduce an on-going NASPA2 "senior student affairs officer roundtable" in conjunction with our expanded SSAO Institute at the Regional Conference;
 - b. Offer faculty-specific initiatives;

- c. Provide timely information on state and national policies that impact our campuses and our students;
 - d. Ensure that senior-level student affairs leaders and faculty are aware of new, and on-going NASPA initiatives and programs.
4. ***Commitment to Community Colleges and Two-Year Institutions*** - Develop and deliver programs focused on supporting student affairs work at community colleges and two-year institutions throughout NASPA2.
- a. Establish a NASPA2 Community Colleges Institute;
 - b. Ensure representation from community colleges and two-year institutions on the Regional Advisory Board and Regional Conference planning committee.
