## NASPA Strategic Plan

*Divisional efforts at addressing the NASPA Strategic Plan:*

### Goal 1

1. Build the capacity to create knowledge and use data to provide evidence that will support excellence in practice.

*Objectives*

- 1.1 Be the primary source of data on the experience of college and university students.
- 1.2 Demonstrate the impact of student affairs on student learning, persistence, and success through scholarship, assessment, evaluation, and research.
- 1.3 Tighten and align the connections among theory, research, and practice.

Division Goal 1: Expand professional development, visibility and communication supporting excellence in practice at small colleges and universities.

- Regional reps are developing regional advisory teams to serve as a conduit for communication of division programs and activities. This has been particularly productive in Regions I, IV-E, IV-W, & VI.
- Leadership team submitting proposals for SCU roundtables at regional and specialty conferences including Regions I, II, III, IV-E, IV-W, and VI, Civic Learning & Democratic Engagement, and Multicultural Institute.
- Planning is underway for a dial-in conference on athletics at the small college. This is being coordinated by Debbie Heida.
- The SCU Listserv is an effective way to obtain information, feedback and ideas regarding SCU matters. The listserv continue to receive good traffic from the members of SCU. We continue to promote subscription by sending out regular email notification.
- The SCU twitter account, @NASPAscu currently has 140 followers. The account is facilitated by Damon Sloan, Dean of Students, St. Francis University.

- Houston Dougharty continues to lead an effort to enhance the relationship between SCUs and graduate preparation programs. Jerry Price has submitted a proposal for a session at the Western Regional conference on careers at small colleges.
- Through the efforts of Bob Gatti and Tim Millerick, we continue to explore ways to work closer with NCAA Division III. Bob Gatti from Otterbein also serves on the Student-Athlete Knowledge Community. This will be a focus of an upcoming dial-in conference.
